**Arrest of Habitual offender in Cr. No. 371/2023, U/s 457, 380 IPC of  
Sathupalli PS.**

The CCS, Khammam Police along with Sathupalli police in joint operation nabbed offenders in H.B. by night case of Sathupally PS in Cr.No.371/2023 U/s 457, 380 IPC.

**BRIEF FACTS OF THE CASE:** On 20.12.2023 at 1400 hrs received a complaint from Koram Laxman Rao, S/o Veernna, Age 38 Yrs, TSSP 15 BN Head Constable, R/o Bethupally Village of Sathupally Mandal, wherein he stated that in between 19-12-2023 between 20-30 to 23-45 hours when his family had gone to attend family function. On return he observed that unknown offenders has broken kitchen door and made entry his house. Further, he reported that gold ornaments weighing 166 grams W/Rs 4,15,150/- and cash Rs 2,50,000 was stolen by the offender. Case in Cr No. 371/2023 U/s 457, 380 IPC was reported at PS, Sathupally.
